Dougherty Historic Home Site

Concerned that a house and surrounding land with great historical significance was about to be lost to future generations, a group of Old Mission Peninsula citizens worked diligently to purchase the Dougherty Historic Home Site. The collaboration of the Grand Traverse Regional Land Conservancy, the Old Mission Peninsula Historical Society, the Grand Traverse Regional Community Foundation, and the Peninsula Township resulted in raising the \$575,000 necessary to buy the house and surrounding 15 acres.



of Mackinaw City. In 1852 Dougherty, followed the Native Americans, moved to Omena and started a new mission there.

Solon Rushmore bought the house and land from Peter Dougherty in 1861. The Rushmores farmed the land and later turned it into an Inn. The Rushmore House with 10 guest rooms catered to steamship vessel passengers. In 1956 it was placed on the Michigan Historical Sites Registry. It remained in the Rushmore family until 1961 when it was sold to Virginia Larson. Upon her death, her sons David and Dan Larson

gave an option to buy the house and 15 acres.

The Dougherty Home, and 162 years of artifacts, requires extensive restoration. When completed it will become an historical interpretive center, archival center and a center for educational and cultural programs of an historic nature. Additional plans for the surrounding 15 acres of farm land call for an historical orchard reflecting farming in the late 19th century and an archaeological site to discover the past.

DOUGHERTY TIME LINE

1700's
Primary mode of transportation is by water, the first areas settled were the tips of landmasses harbors. The Ottawa & Chippewa Indians settled in Old Mission, Elk Rapids, Omena.

1839
Rev. Peter Dougherty established mission at Elk Rapids where local tribes plan to unite, building a cabin and school. Later that year, Chief Ahgosa, head of the Old Mission Tribe convinced Rev. Dougherty to move his mission to Old Mission, promising transportation and living quarters.

1842
Rev. Dougherty build the first frame home north of Grand Rapids and south of Mackinaw Island. It is a ten bedroom house and it still stands today on Mission Rd.

1847
Captain Boardman buys 400 acres and builds the first saw mill with help from OM settlers & Native Americans.

1850's
First post office established at Old Mission. Perry Hannah, Tracy Lay & James Morgan form the Hannah, Lay & Co & buy the Boardman's sawmill. Rev. Dougherty moves with the Indians to the "New Mission" at Omena. Post office established in Old Mission.

1860's
Sale of Dougherty Homestead in Old Mission to Solon Rushmore recorded in 1861. Old Mission Inn the first Inn is built built in 1869.

1870's
The Lighthouse Station is built. Duranty Rushmore, brother of Solon, buys the Dougherty House and continues to farm the land.

1880's
William H. Rushmore arrives, continues farming his father's land and opens the large house as an inn that thrived in this era providing summer lodging for resorters and their friends. The village of Traverse City is incorporated.

1961
Virginia Larson purchases the Dougherty/Rushmore House and it remains unoccupied.

2004
Grand Traverse Regional Land Conservancy signs an option to buy and preserve the historic Dougherty/Rushmore home.

2006
The Dougherty Historic Home Committee raises sufficient funds to purchase the Dougherty Home and Property.

Located approximately 18 miles up the peninsula, the house was built in 1842 by the Reverend Peter Dougherty and the Native Americans. He was sent to the Grand Traverse Region by the Presbyterian Board of Missions to start a church and school for the Native Americans that inhabited the area. In May of 1839 he and his assistant built a school in Elk Rapids and by June of 1839 Dougherty established his mission in Old Mission.

By 1842 his settlement consisted of a church, schoolhouse, wigwams, cabins and his own wood-frame house. The house is believed to be the first post and beam house north of Grand Rapids and south

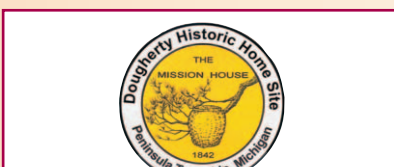
